- **MECON Executive Association**

The executives of MECON have a formal body as MECON Executives Association (MEA) which is elected every two years. The committee has a President, Two Vice-president, General Secretary, Four Joint Secretaries, Treasurer and executive committee members.

- **MECON Employees Union**

The non-executives of MECON have a formal body as MECON Employees Union (MEU) which is registered body. The committee has a President, Secretary, Vice-president, Treasurer and Executives Committee Members. Election is held every two years for the selection of the team.
